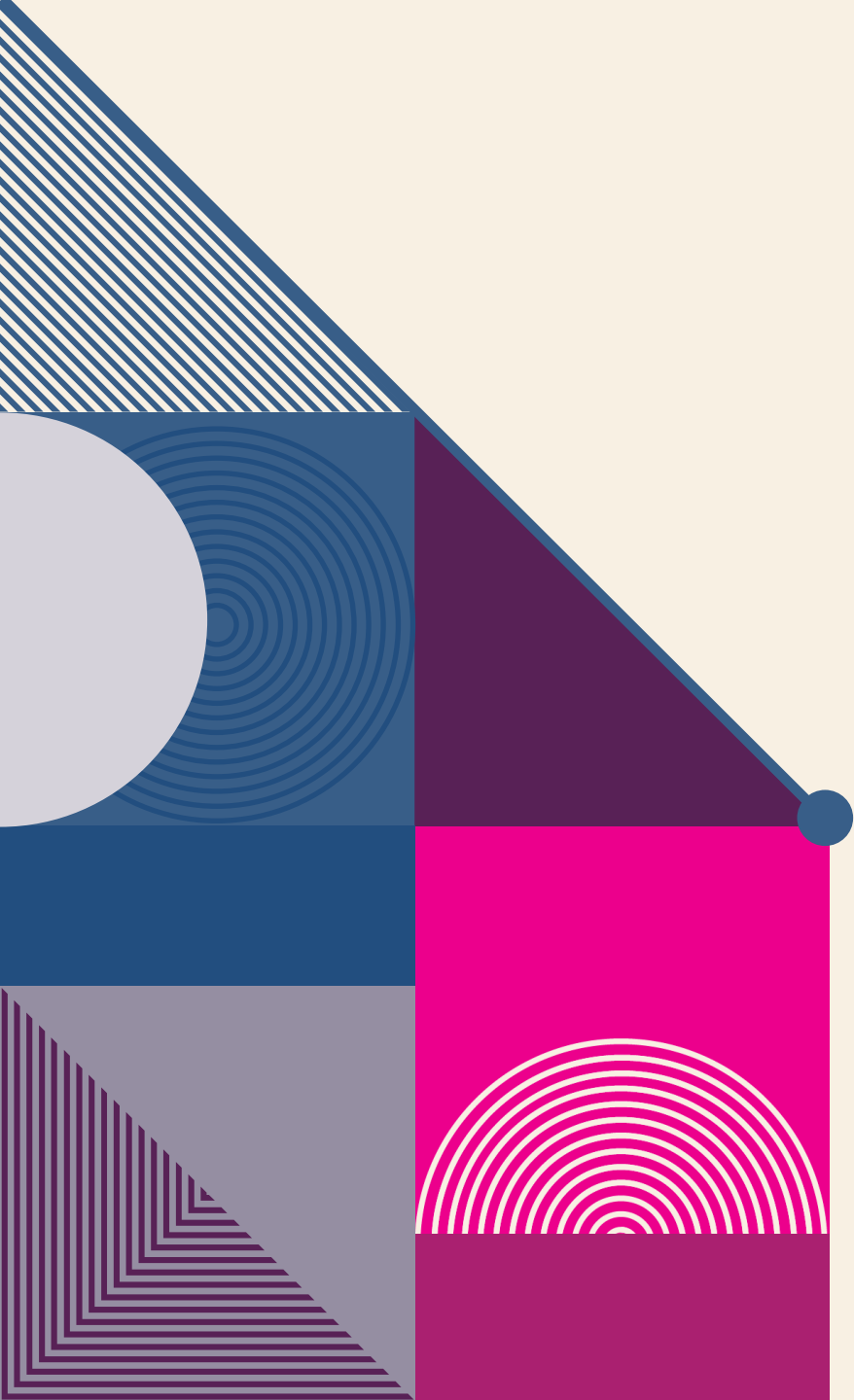

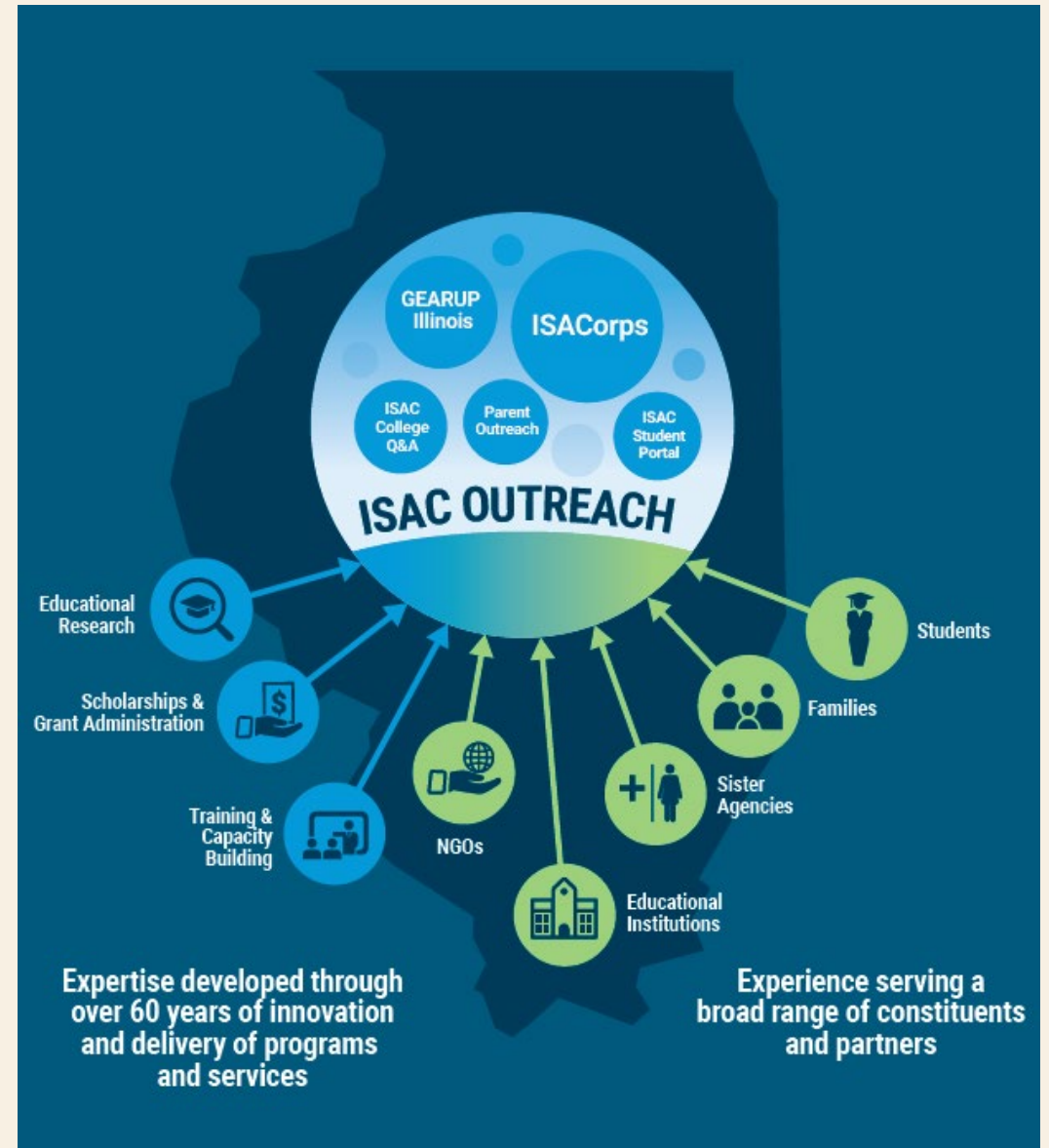

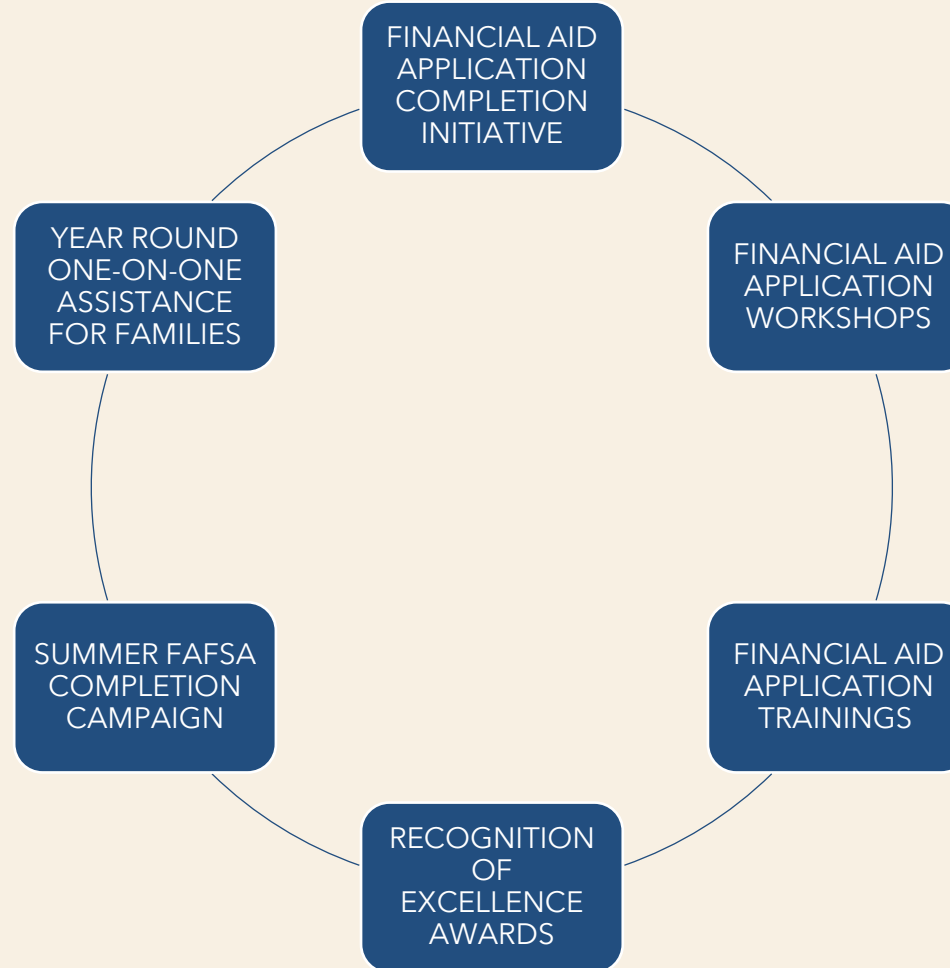

# THE UNIVERSAL FREE APPLICATION FOR FEDERAL STUDENT AID (FAFSA®) COMPLETION POLICY

- Illinois became the second state to adopt the policy
- Each state determines how the criteria for the policy and how it is implemented
- Illinois' policy took effect in the 2020-21 school year
- We were the only state for the 21-22 FAFSA cycle to have an increase in completion rates
  - Before our policy took effect, our completion rate was in the 60% range

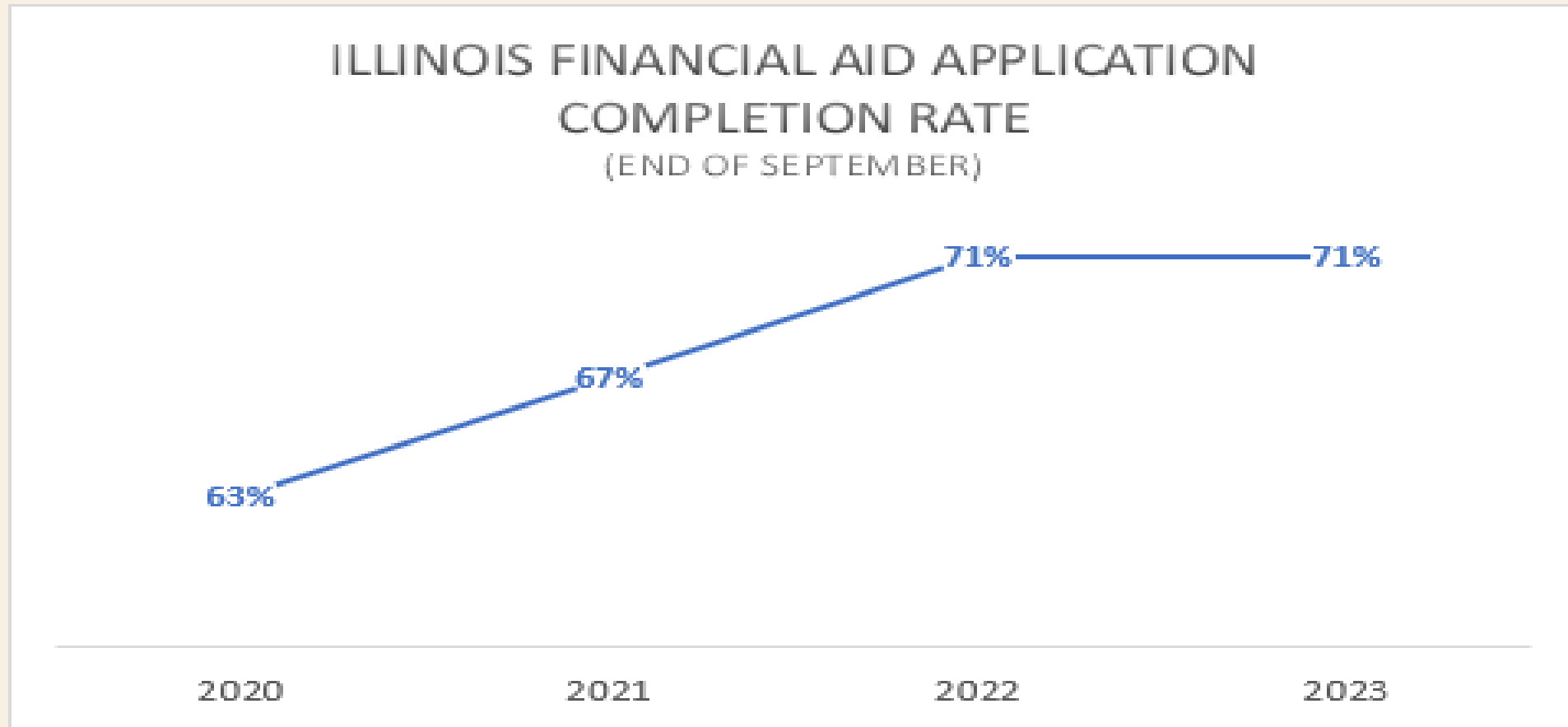
# FINANCIAL AID APPLICATION COMPLETION RATES

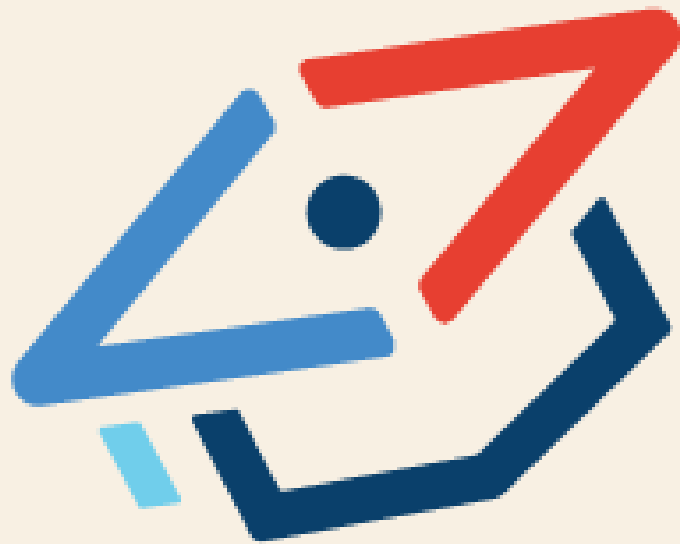
