

# KANSAS HIGHLIGHTS

2023-2024

#### **OVERVIEW**

Kansas enacted authorizing legislation in 1990 to join the Midwestern Higher Education Compact (MHEC). Over the past 35 years, commissioners, commissioner alternates, and members of advisory committees from Kansas have provided and continue to provide important governance and strategic direction for MHEC. Kansas Rep. Barbara Ballard served as MHEC's board chair in 2023-2024.

### **HOW MHEC BENEFITS KANSAS**

- ► **Strong return on investment.** Kansas received a 46-fold return on annual compact membership commitment of \$115,000:
  - » Technology Contracts. Kansas entities saved \$1.63M through MHEC contracts with Dell, Oracle, Parchment, Xerox, and others.
  - » *Distance Education*. By participating in the Midwestern-State Authorization Reciprocity Agreement (M-SARA), Kansas saved approximately \$1,729,800 and avoided a costly state-by-state, institution-by-institution approach.
  - » Tuition Reciprocity. Kansas students and their families who participated in the Midwest Student Exchange Program saved more than \$1.98M.
  - » Student Health Insurance. 7,401 students at 7 Kansas institutions participated in MHEC's contract for student health insurance.
  - » Master Property Insurance Program. Five colleges and universities and the Kansas Board of Regents received dividends of \$221,368 for program participation.
- ▶ \$5.34M in total annual savings. Kansas colleges, universities, school districts, state and local governments, and students and their families realized more than \$5.34M in cost savings through MHEC's contracts and programs.
- Open Education Resources. MHEC support Kansas's statewide open education resources (OER) committee with funding for a pilot project to incentivize the use of OER for Kansas Board of Regent Systemwide Transfer courses, the outcome of which is a public-facing list of recommended resources.
- Professional Development and Support. Kansas leaders attended MHEC's FAFSA Summit and follow up state conversations. Nine technology leaders engaged in MHEC's free professional development and networking.
