FY 25 Appropriations


- Congress has passed a continuing resolution to keep the federal government funded until <u>December 20, 2024</u>.
- The House and Senate are still far apart on spending priorities:
 - The House bill (GOP) includes substantial cuts to higher education programs, particularly teacher education, campus childcare, and campus-based aid.
 - The Senate either flat-funds or gives modest increases to education programs.
- Congress is expected to pass another CR until 2025
 - Dems are pushing for end-of-year omnibus, House GOP wants CR until March. Scalise calling for September.




FY25 Appropriations

Higher Education Issues

- FAFSA Deadline Act
 - Mandates an October 1 start date
 - Passed the House with near-unanimous support, higher ed community support
- Bipartisan Stop Campus Hazing Act (House)
 - Requires institutions to report hazing incidents under the Clery Act
 - Requires preventative educational programs
- End Woke Higher Education Act
 - Ensures colleges are not forced by accreditors to commit to DEI principles
 - Makes free speech a campus condition of receiving Title IV
 - ACE has expressed concern over the bill



Other Issues

- Other issues in lame duck
 - Disaster assistance
 - Defense authorization
 - Farm Bill
 - Confirm judges (Senate)





FAFSA Beta Testing Update



- The U.S. Department of Education is in the 4th and final round of beta testing for the 25-26 FAFSA
 - More than 14,000 students have submitted a FAFSA
 - No critical bugs have been reported
 - 95% satisfaction rate in beta testing
- The form is expected to be released prior to the end of the month

Court Decisions/Cases

- Regulatory Policy: Loper Bright Enterprises v. Raimondo
 - This decision struck down the 40-year Chevron defense
 - Chevron: Two-step approach
 - Step One: Has Congress spoken to the precise question at issue?
 - If yes, then must give effect to the intent of Congress.
 - If no, move to Step Two
 - Step Two: Is the agency's interpretation reasonable?
 - If yes, then defer to the agency's interpretation
 - If no, the court can provide its own interpretation or send it back to the agency for reconsideration.
 - Key question: To what extent should courts defer to federal agencies in interpreting federal laws?
 - The Court ruled that ambiguity "is simply not a delegation of law-interpreting power" and that the APA and the Constitution requires <u>courts</u> to decide on questions of law. Courts, not agencies, should have the final say. There is a "best reading" of the law from courts, not just a permissible one.
 - This shifts power to the courts from the executive branch, could limit regulations





Court Decisions/Cases


- <u>Biden-era Higher Ed Regulations:</u> Biden-era legal efforts on student loan forgiveness and Title IX likely to be abandoned
- Overtime rule
 - Overtime rule applies to non-exempt employees who earn below a threshold (\$35,568)
 - President Biden had proposed increasing the threshold to \$58,600
 - Overtime rule has been blocked by Texas-based federal judge
 - Trump administration unlikely to continue lawsuits, retain current policy

119th Congress-Education and Workforce Committee

- Virginia Foxx will be stepping down as chair
- Competition between Rep. Burgess Owens (R-UT) and Rep. Tim Walberg (R-MI) for chair
 - Owens supports closing Department of Education, replacing it with something better
 - Walberg said will focus on workforce-related issues
 - Potential for College Transparency Act? Workforce Pell?
- Ranking Member: Rep. Bobby Scott (D-VA)








2024 Election-Senate

119th Congress-Senate HELP Committee

- Committee Chair: Sen. Bill Cassidy (R-LA)
- Ranking Member: Sen. Bernie Sanders (I-VT)
- Cassidy Priorities:
 - College Transparency Act: Create a federal unit record data system
 - Understanding True Cost of College: Uniform financial aid letters
 - Informed Student Borrowing Act: Clear Information about student loans
 - SAVE for Students Act: Lower loan repayment options for 9 to 2
 - GOAL Act: Ends Graduate PLUS Loans and limits graduate school borrowing
 - Other Issues: Opposed to DEI spending, Biden loan forgiveness, and concerned over campus protests on Middle East





Incoming Trump Administration

- <u>Regulations</u>: Trump Administration will likely target Biden-era higher ed regulations for recission or revision
 - Gainful Employment and Financial Transparency likely to be removed
 - Biden-era Title IX changes, particularly on transgender protections
 - Biden-era student loan forgiveness efforts will likely be curtailed
 - Any regulation that has not fully completed the rulemaking process is likely to be discontinued
 - Other Biden-era regulations will be targeted
- <u>Financing:</u> Funding for financial aid. Potential focus on risk-sharing and College College Reduction? Budget proposals will be limited.
- Immigration: Deportations remain a concern for higher ed leaders, along with visa issues
- Other Issues: There will likely be a greater focus on free speech, combating antisemitism, and new restrictions on DEI spending





Trump Statements on Higher Education


- Make Colleges and Universities Sane and Affordable
 - "Republicans will fire Radical Left accreditors, drive down Tuition costs, restore Due Process protections, and pursue Civil Rights cases against Schools that discriminate." (Agenda 47)
- Accessible Higher Education
 - "To reduce the cost of Higher Education, Republicans will support the creation of additional, drastically more affordable alternatives to a traditional four-year College degree." (Agenda 47)
- Abolish U.S. Department of Education
- Create a federally funded online university
- More taxes on university endowments





Project 2025

- Has been disavowed by Trump campaign, but was written by former Trump Administration staffers
- These changes will face an uphill climb on Capitol Hill
 - Eliminate the Department of Education
 - Move Office of Postsecondary Education programs to the Department of Labor
 - Block grant funding for HBCUs and Tribal Colleges
 - Move the NCES to Census
 - Spin off Federal Student Aid to separate corporation overseen by Treasury
 - End loan forgiveness
 - Overhaul accreditation
