- Direct admissions

- Growth of last-dollar tuition-free public college programs
- Overall increases in state higher education subsidies
- Tuition freezes
- Continued growth of mandatory FAFSA policies
- Inflation remains a concern
- Focus on restricting/eliminating DEI programs
- Bans on transcript withholding
- Efforts to limit/eliminate tenure
- Interest in addressing student basic needs (housing, food, mental health, etc.)

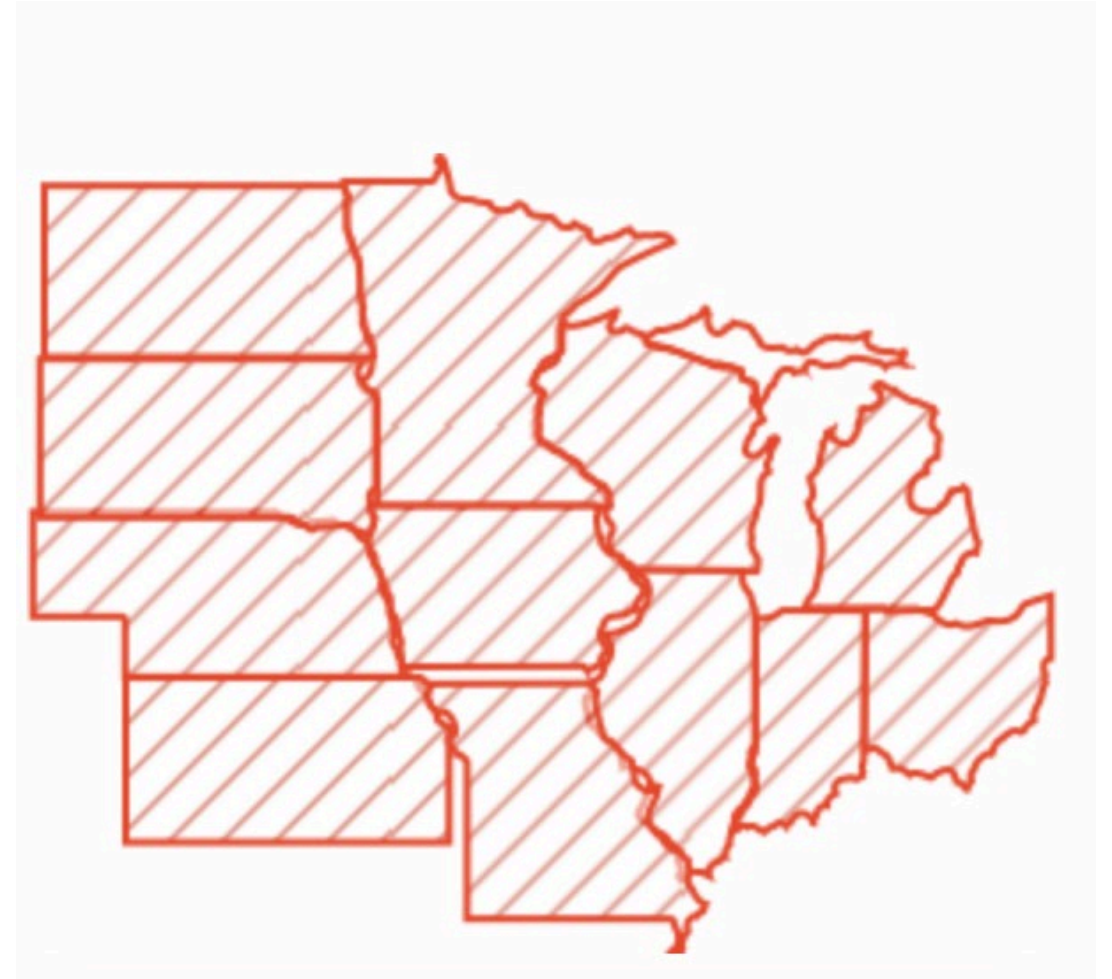

- Illinois
- Indiana
- Iowa
- Kansas

MHEC States and Higher Education

- Illinois

- First state to offer free test prep and licensure prep to public university students
- Freshman enrollment increases
- Task Force on higher education in prison
- New measure to address student hunger on campus
- Largest increase in higher education funding in 20 years, an increase of 12.4% for a total investment of \$2.53 billion
- Reforms to strengthen to the AIM HIGH Grant Pilot Program

MHEC States and Higher Education

- Indiana

- Historic expansion of the 21st Century Scholars Program
- Movement to e-transcripts
- Increased number of students enrolling in higher education, increased college completion
- Launched Indiana Pre-Admissions: Your Path to College will use high school students' GPAs or SAT scores to let them know which colleges they might be accepted at statewide
- Mandatory FAFSA
- Ban on transcript withholding

MHEC States and Higher Education

- Iowa
 - Enrollment increases at the three regent universities
 - Rollout of income and debt dashboard
 - Rollout of majors for high-demand worker grants
 - Possible new restrictions on DEI activities

MHEC States and Higher Education

- Kansas

- Growth in college enrollment
- Renewed focus on improving teacher preparation
- Created a free application period for applying to state colleges and universities
- New restrictions on DEI “oaths” at public colleges and universities

MHEC States and Higher Education

- Michigan

- Record enrollment for first-year students due to the Michigan Achievement Scholarship
- Considering a mandatory FAFSA bill
- Expansion of the Michigan Reconnect Program
- Creation of a new department (MiLEAP) that will include higher education
- 10 Michigan universities to accept any state high school grad with 3.0 GPA or better
- State budget has significant increases in higher education

MHEC States and Higher Education

- Minnesota

- New investments to freeze tuition at Minnesota State
- Free public college to those making less than \$80,000 annually
- Free college for American Indians
- Full of of attendance college for former foster youth

MHEC States and Higher Education

- Missouri

- Historic increases in higher education funding, including a new veterinary school at the University of Missouri
- Consideration of a new funding model for higher education
- New investments in capital projects

MHEC States and Higher Education

- Nebraska
 - 2.5% budget increase for each of the next two years at the University of Nebraska
 - Steady enrollment at U of Nebraska System

MHEC States and Higher Education

- North Dakota

- 1.6% increase in enrollment
- Record increase in funding with a 15.5% funding bump, new funding for a national security corridor, and funding for Career Builders Scholarship and loan forgiveness
- Consideration of changes to state financial aid program in response to Minnesota's free college program

MHEC States and Higher Education

- Ohio
 - Enrollment numbers are holding steady
 - New teacher apprenticeship program
 - Funding for “intellectual diversity centers” at five of the state’s public colleges and universities
 - Debate over a measure that would overhaul state higher education policy regarding DEI, tenure policy

MHEC States and Higher Education

- South Dakota
 - 2% growth in enrollment
 - New tuition offsets for those receiving SNAP benefits at the state's four technical institutes
 - Made a tuition freeze a priority
 - Focus on teacher apprenticeships
 - Expansion of the South Dakota Advantage program, which offers in-state tuition to students from neighboring states

MHEC States and Higher Education

- Wisconsin
 - Slight growth in enrollment
 - Launch of direct admissions at Universities of Wisconsin
 - Legislative focus on DEI issues, free speech
