#### It Was Time to Review

- Midwestern Higher Education Compact's (MHEC) MSEP was established in 1994
- Complete change of the higher education environment
- Is MSEP still relevant



## Decline of Enrollment Numbers



#### Reason 1: Lack of population growth

A December 2019 report from the National Student Clearinghouse® Research Center™ revealed a nationwide decline in fall college enrollments of more than 2M from 2012-2019 with the trend expected to continue.

- Traditional-aged college students
  - Loss of job opportunities for parents caused migration outside of the Midwest
  - Great Recession led to less childbearing
  - Decline of high school graduates
    - After 2025, according to the Western Interstate Commission for Higher Education's *Knocking at the College Door* report, the number of high school graduates will drop from 720,000 to 670,000



#### **Reason 2: COVID**

- Traditional-aged college students
  - Increase in gap years
  - Educational uncertainty
  - Financial concerns
    - Numerous conversations in the media about student debt crisis
  - Stay closer to home
  - Avoid COVID hotspots



## Reason 3: Lack of interest in the traditional college experience

- Traditional-aged college students
  - Seek shorter, career-focused programs that don't warrant an out of state move
  - Growth in online courses and programs
  - Stackable credentials that don't lend themselves to a four-year residential college experience
  - Increase in the number of programs aligned with needs of local employers



#### Reason 4: Decline of Out-of-State Tuition Model

- Non-differential tuition rates
  - Illinois 5 institutions
  - Michigan 4 institutions
  - North Dakota 4 institutions
- Institutions have other means to bring out-of-state tuition down to in-state levels
  - Merit
  - Athletic
  - Tuition break

- Examples
  - Southeast Missouri State University Redhawks' Achievement Award
  - University of Michigan Dearborn's Tuition Differential Scholarship
  - Both cover the difference between in-state and out-of-state tuition



#### Reason 4: Decline of Out-of-State Tuition Model

- Loss of revenue from not charging higher out-of-state tuition is compensated by the greater number of out-of-state students attracted to the school because of the price reduction
- Educational policymakers have criticized the out-of-state tuition model as ineffective and inefficient; hinder students from attending the college that is the best fit to meet their education goals

Over the last three years, MHEC's MSEP has seen • 13 institutions and two states withdraw from the program



## Increase of Enrollment Numbers



#### Increase of Enrollment Numbers with Implications for Reciprocity Programs

- Students from traditionally underserved populations including low-income, firstgeneration are enrolling more
  - National Center for Education Statics projections suggest between 2016 and 2026, the enrollment growth of
    - Black students: 20%
    - Hispanic students: 26%
    - Students from two or more races: 36%



- Caveats
  - Likely to attend
    - college close to home
    - part-time
    - two-year institutions

These are undergraduate programs. SREB and WICHE have separate similar initiatives for graduate studies.
