OER IN ILLINOIS HIGHER EDUCATION SURVEY

The Illinois Board of Higher Education and the Illinois Community College Board released the survey in 2020. It assessed the status of OER usage and integration at higher education institutions. 65 institutions responded.

ILLINOIS OER SENIOR LEADERS SEMINAR

70 leaders from higher education institutions attended the seminar in 2021. Sponsored by MHEC and offered by the Open Education Network, it clarified rationales for open education initiatives and the potential for connections between open education and strategic priorities.



COLLEGE COURSE MATERIALS AFFORDABILITY AND EQUITABLE ACCESS TASK FORCE



2022 legislation created the task force to conduct a study on affordability and equitable access course materials.
