MHEC leverages the knowledge and expertise of postsecondary leaders to generate collaborative solutions to challenges in higher education.

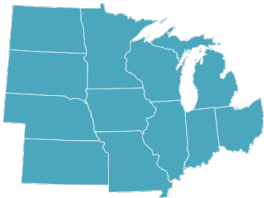


MHEC's contracts and programs save colleges, universities, and students in its member states valuable time and millions of dollars annually.

About the Compact



MHEC was established in the early 1990s through the enactment of legislation recommended by the Midwestern Legislative Conference of The Council of State Governments. MHEC is funded by member state commitments, program income, and foundation grants. Member states are Illinois, Indiana, Iowa, Kansas, Michigan, Minnesota, Missouri, Nebraska, North Dakota, Ohio, South Dakota, and Wisconsin. Minnesota enacted authorizing legislation in 1990 to join MHEC.

How MHEC Benefits Minnesota

Minnesota received a 120-fold return on its MHEC membership commitment of \$115,000 in 2024-2025.

New Upcoming Savings & Financial Opportunities

Each member state is eligible for a Strategic Impact and Innovation Grant of up to \$250,000 over two years from MHEC to advance innovative ideas and solutions in higher education.

Additional Savings for Minnesota Students & Families

The Midwest Student Exchange Program (MSEP) has helped students and families save millions of dollars by making it more affordable for non-resident students to attend out-of-state colleges and universities. This program is currently being reviewed in response to changes in tuition reciprocity practices across the region.



Minnesota Engagement with MHEC Policy Initiatives & Capacity-Building Opportunities

Open Educational Resources (OER)	MHEC provided a \$5,000 grant to the University of Minnesota to support the Open & Affordable Practices OER Pathfinder Program, and support for under-resourced postsecondary and K-12 schools to launch sustainable OER initiatives.
Dual Enrollment	Several Minnesota higher education leaders participated in MHEC's July State Policy Workshop to advance dual enrollment efforts in the state. MHEC also is supporting work associated with the College High School Alliance and MN P-20 Partnership project to increase dual enrollment access for rural students.
Access & Affordability	Leaders from many Minnesota state agencies, colleges and universities, philanthropy, and nonprofit sector attended MHEC's FAFSA Summit and other webinars to address issues and opportunities related to college access and affordability.
Technologies Community	Minnesota has strong engagement in MHEC's Technologies Community. Dr. Kim Lynch from Minnesota State serves on the Technologies Executive Committee and several members participate and provide leadership to the group's annual conference.

Research Requests

MHEC's policy and research team provided detailed reports in response to requests from Minnesota higher education leaders and legislators on topics including:

- Reducing practicum barriers to mental health licensure
- Full-time enrollment
- Out-migration of college students
- State support for college access and success initiatives

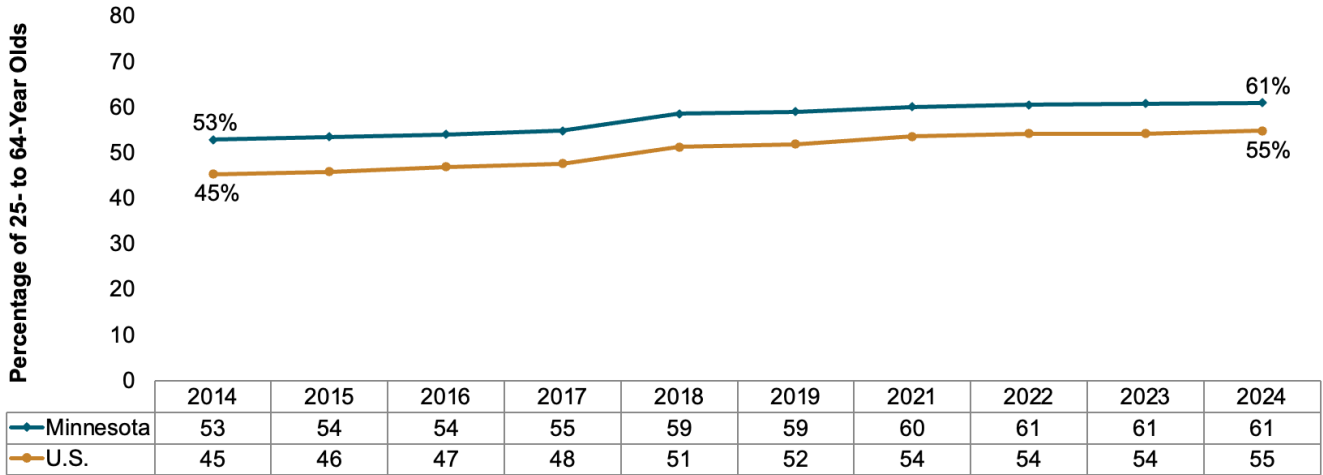

Key Indicators for Higher Education in Minnesota

ATTAINMENT: Minnesota has remained consistently higher than the nation in attainment. About 61% of Minnesotans have a postsecondary certificate or higher, compared to 55% nationally.

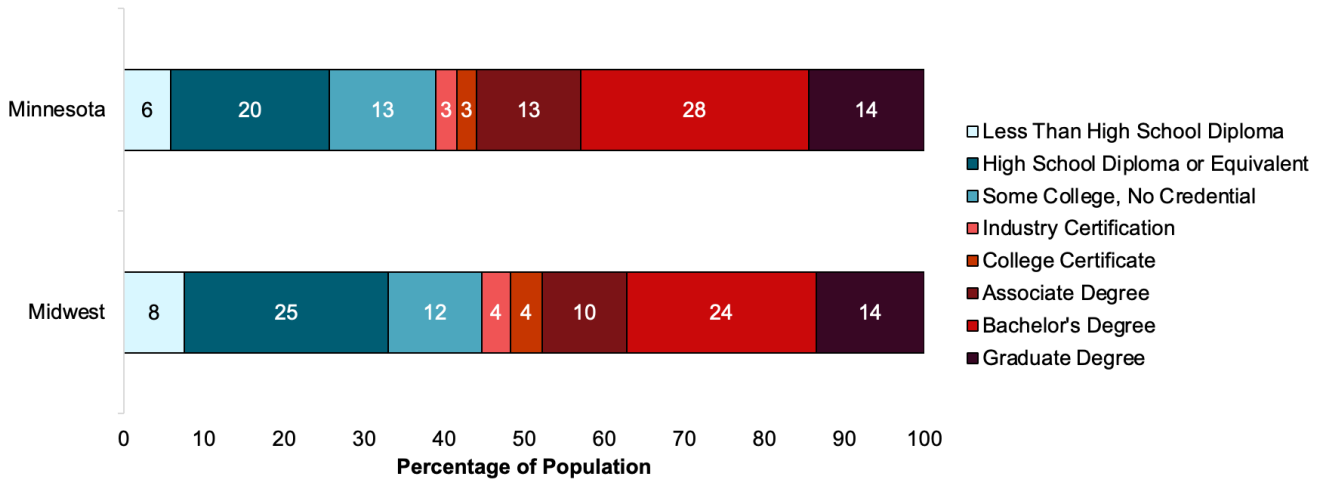
Percentage of 25- to 64-Year-Olds in Minnesota Who Have Attained a Postsecondary Credential

ATTAINMENT: Minnesota residents have attained various types of postsecondary credentials, ranging from industry certifications and college certificates to bachelor’s and graduate degrees; 39% of residents do not have a credential beyond high school.

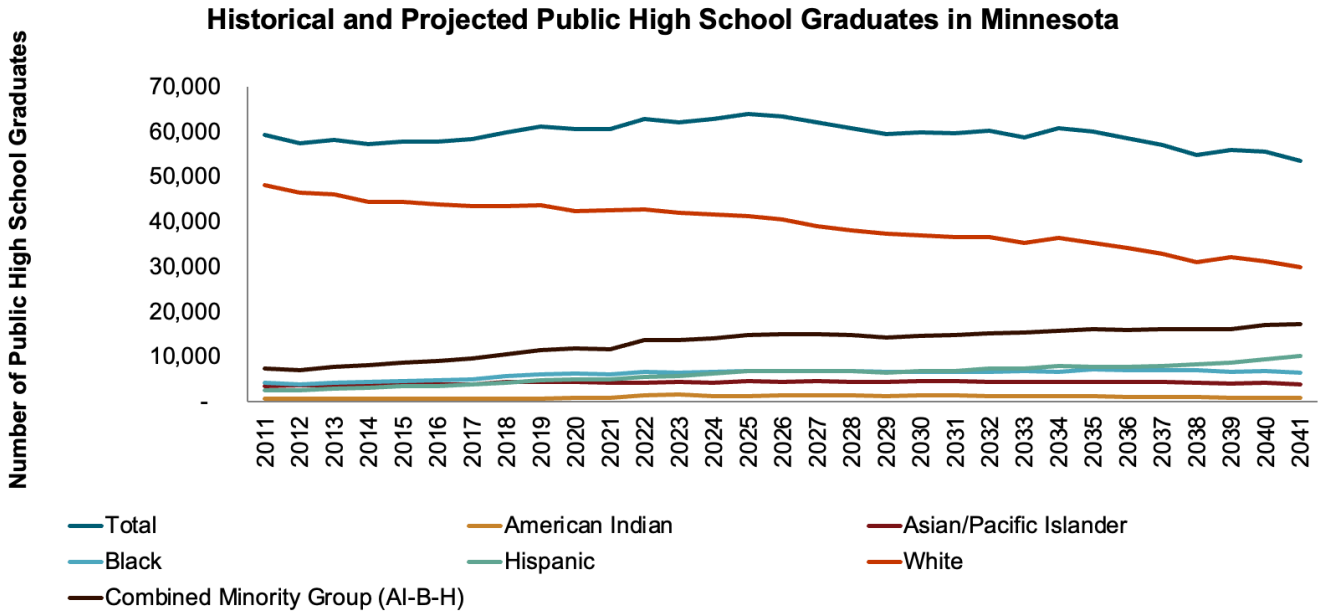
Educational Attainment Distribution of Minnesota Residents Ages 25-64, 2024

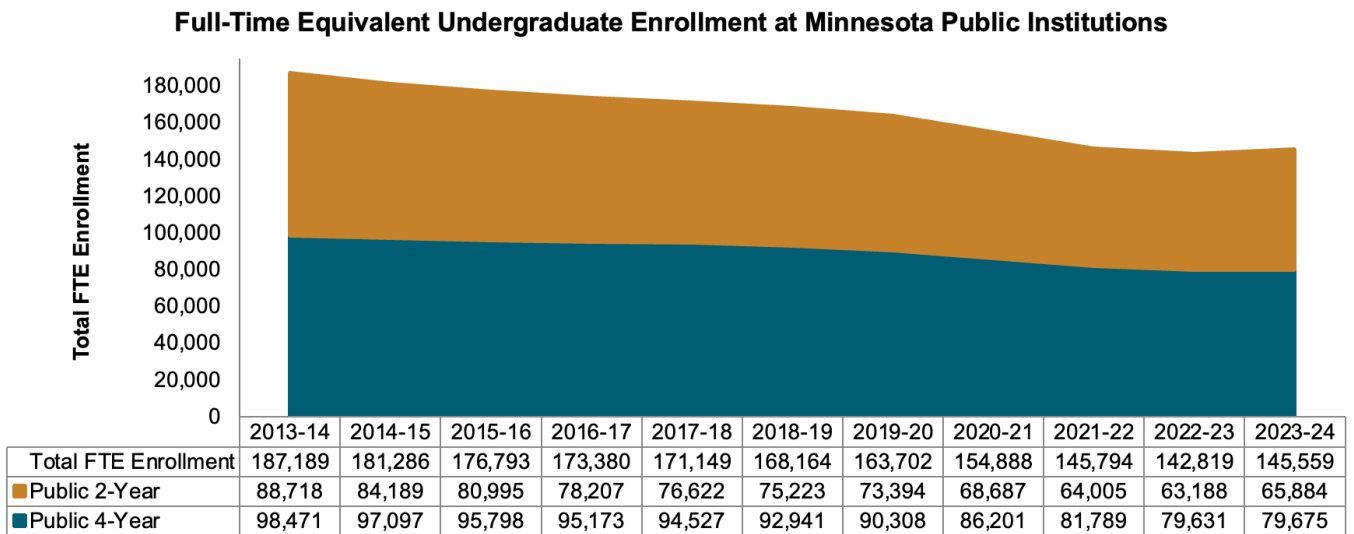

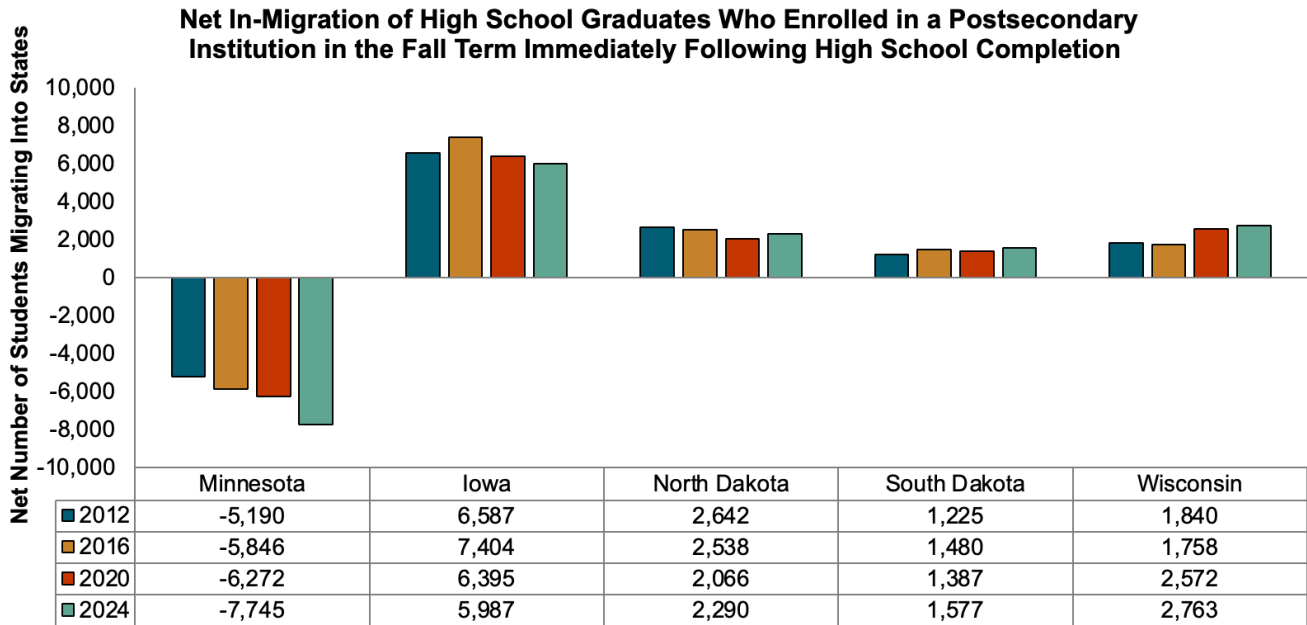
ENROLLMENT: Undergraduate enrollment has declined at public two- and four-year institutions in Minnesota over the past decade but started to increase in 2023-24.

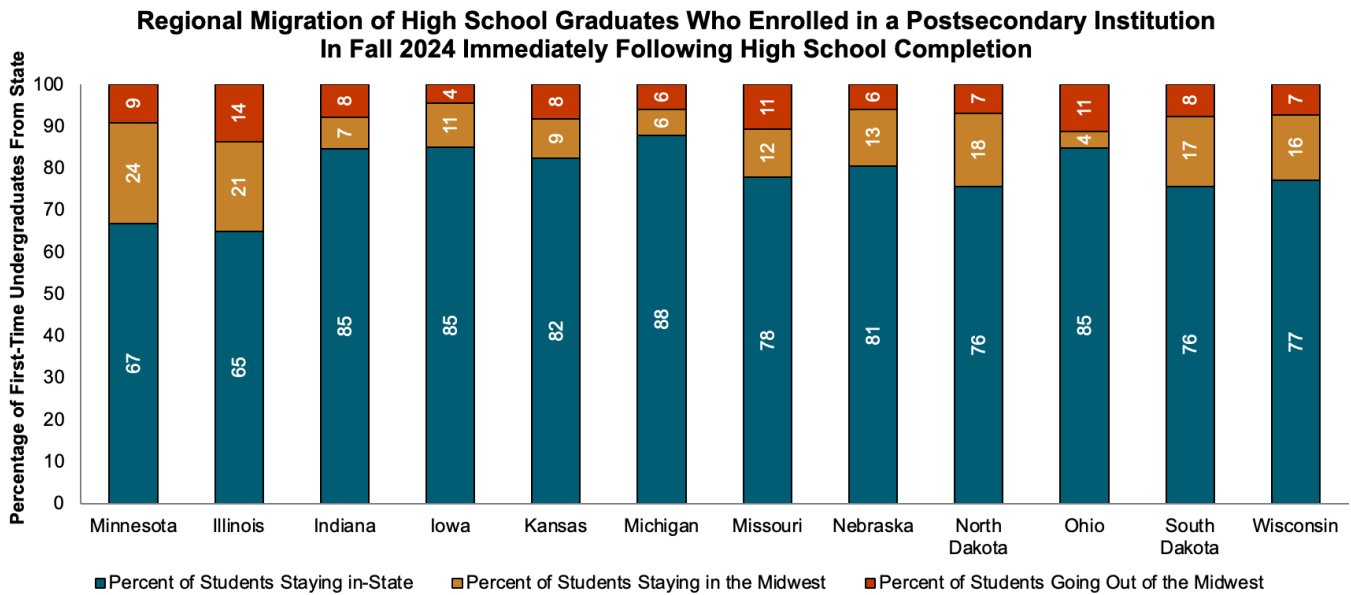


MIGRATION: More students migrate out of Minnesota than migrate in.

ENROLLMENT LOCATION: Of first-time college students from Minnesota, 67 percent enrolled in state, 24 percent enrolled elsewhere in the Midwest, and 9 percent enrolled outside the Midwest.

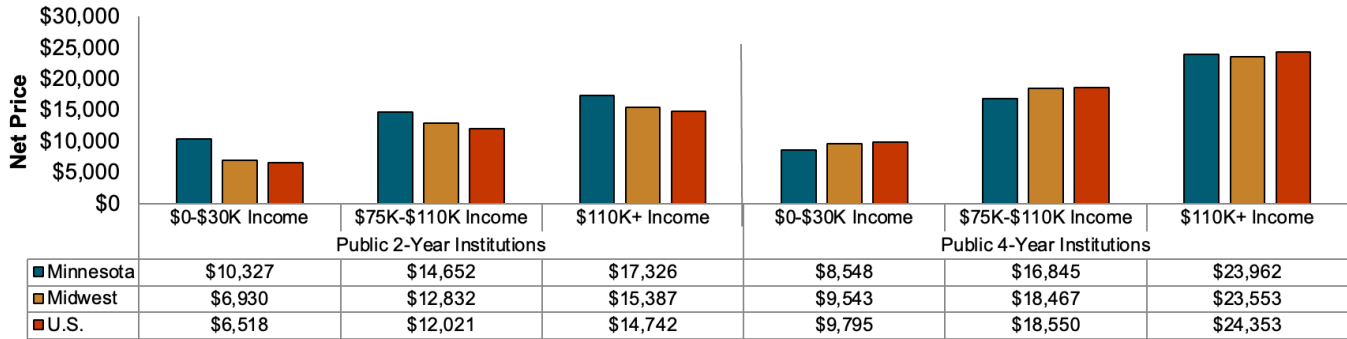

COLLEGE PRICE: At public two-year colleges, average net price for low- and higher-income students in Minnesota is greater than the Midwest and national averages. At public four-year institutions, the net price is lower than the regional and national benchmarks for low-income students and students in the \$75K-\$110K income group; it is also lower than the national average for students in the highest income category.

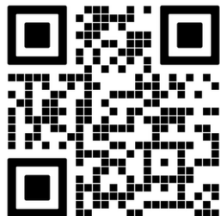
